

Terms & Conditions

i. WIN AN ALL-EXPENSE PAID TRIP TO BANGKOK TO WATCH LIVERPOOL FC VS MANCHESTER UNITED FC

All entries received after the contest period will not be entertained.
- myTukar reserves the right, at its absolute discretion, to vary, postpone, reschedule and/or extend the contest period and/or cancel/terminate the contest at any time without prior notice.
- 10 winners will be shortlisted [**“Winner”**], who will be contacted to complete a quiz. Customers that correctly complete the quiz win the contest. The contest winner will be announced by 1st of July 2022. Total of ten (10) prizes (‘Prizes’ of the same value) to be given to ten (10) eligible winners and each winner will be winning 2 platinum tickets worth 764 USD inclusive of flight and accommodation arrangements for 2 pax.
